- surface: steel / lubricant: glycerol.

**S3** = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil, water penetration resistance and absorption (water-repellent upper), penetration resistance, cleated outsole; **HRO** = resistance to hot contact of the outsole; **HI** = heat insulation of sole complex.

Note 1: the penetration resistance of the synthetic stitch proof insole tends to decrease with the diameter of the perforating object; in return the synthetic insole offers more protective surface and ergonomics advantages (flexibility, insulation, humidity and impact absorption).

Note 2: the footwear also meets the requirement in accordance with IEC 61340-5-1:2016 (IEC 61340-4-3:2001) for the electrical resistance **ESD** class 1 (electric dissipative footwear).
